Failure to provide complete and necessary information may delay the approval process.

The following changes/additions are requested to be made;

Home exterior includes painting*, lighting, siding, stone, brick, stucco, roofing, fascia and soffit, gutters, chimney, windows and trim, entry door, patio doors, shutters, awnings, porch/patio decks, screening/enclosures, driveway and planters.
Paint Colors _____

* - Please note that a two foot by two foot sample of the new color(s) will be placed on the side of the home for approval.

The Trim must be lighter than the home color and all fascia must be the lighter color of the house or white.

Shutter & front door color must also be specified for approval. Driveway cannot be painted or stained.

PAINT APPROVAL IS ONLY VALID FOR 30 DAYS. AFTER 30 DAYS YOU MUST RESUBMIT APPLICATION

Landscaping all changes or additions must include site plan, size, number, location and type of plants for approval.
Pool Additions detailed site plan showing pool and equipment locations. All equipment must be screened from view of street.
A refundable deposit of \$750.00 is required before any construction can begin.

Solar Heating detailed site plan required.
Propane Tank must be obstructed from view of street by landscaping. A site plan is required before installation.
Play structures shall be located at rear of dwelling, in case of corner lot, be on the inside portion of the lot within setback.
Fences vinyl or wood, with the finished side facing out. Wood fences shall be stained approved color. Wood fences must be re-stained every two years. Fences seen from the street must be screened by landscaping. Fence shall be 10 feet behind front line of home. Fences along lakes and ponds shall be no more than 4 feet tall at rear of home. NO fencing shall be permitted at homes adjacent to the golf course. All fence styles must be approved before installation.
A \$500.00 refundable deposit is required before construction can begin. A site plan is also required
